#### **ENVIRONMENT**

#### 138.LEAD COUNCILLORS REPORT

Several fallen branches/trees in Dawes Common and across the nearby footpaths have been dealt with – trees cut up and footpaths made good.

TRDC have advised they will no longer be emptying 19 litter bins on SPC land (for free) and we need to find a service provider. The Clerk has written to TRDC requesting an extension of the current service to the end of July to allow SPC time to make alternative arrangements, which has been agreed. SPC will need to secure quotes from three potential suppliers, which could include TRDC as a paid for service. Cllr Garvey suggested we ask each supplier to quote for the following levels of service:

- 1. Standard bin pick up to go to land fill
- 2. Bin pick up to be separated for recycling by the supplier
- 3. Additional bins 1 x standard and 1 x mixed recycling at each location

#### 139.WOODLAND MANAGEMENT PLAN

A meeting was due to take place early this month with Robert Young from the HCC Countryside Management Team to look at the next iteration of the 10-year Woodland Plan following comments from Councillors, Sustainable Sarratt and the Wildlife Volunteers during site visits to Commonwood Common that took place in April on his original ideas. Unfortunately, Richard has had to take early paternity leave. The next meeting is therefore anticipated in early July.

#### **PLANNING**

#### 143. LEAD COUNCILLORS REPORT

The Chair advised that effective next month Cllr Farman, as the new Lead for Planning, would be presenting future agenda items on planning, but for this meeting this would be led by her. However, both Cllr Farman and Cllr Rugg had been involved in prepping for the review of this month's planning applications (see below).

The Chair expressed thanks to Cllr Gell who attended the TRDC Planning Committee on 27 May to raise SPC's objections to the planning application for Petherick Pastures in Buck's Hill which was subsequently refused by the Planning Committee.

The Chair advised TRDC's new Local Plan (Reg 18 site consultation) was due to be published on Friday 11 June, with a six-week consultation period. It was agreed to schedule an extraordinary SPC meeting on Wednesday 23 June to review the implications for Sarratt, and formulate our response to TRDC, as well as agree what communication/engagement should be made to Sarratt parishioners. It was noted that the Chandlers Cross Residents' Association (CCRA) is keen to 'leaflet drop' residents to speak up about the plan. A request has been made to the

CCRA to desist from leaflet dropping Sarratt residents until SPC has had chance to review the sites being considered under the new TRDC Local Plan at the meeting, now proposed for 23 June.

Permission in Principle: Change of use to residential and construction of two single storey houses with associated residential curtilages.

SPC: Objection.

Withdrawn by applicant

It was noted that an appeal has been lodged for Application No: 20/2802/FUL (The Old Cattle Shed, Red Lion Lane, Sarratt, WD3 6BN) for the erection of a multi-purpose agricultural barn at the bottom of Red Lion Lane. SPC objected to the application which was refused by TRDC.

# **HIGHWAYS**

#### **146.LEAD COUNCILLORS REPORT**

No significant changes since the last report. Roadworks continue throughout the Parish as HCC Highways and other contractors clear the Covid-19 backlog.

Focus over the last month has concentrated on:

- Police liaison over safety concerns for Sarratt Road, to ascertain their views.
- Progressing safety and road improvements, especially Church Lane, Red Lion Lane and outside York House School.
- No response as yet on the grant submitted by SPC to HCC for monies to improve cycle safety.

Looking ahead:

- Seek to improve liaison over road closures between HCC and contractors.
- Requirement for definitive improvements on Bucks Hill the road surface is a complete disgrace, there are more pot-holes and patch repairs than actual road surface.

Unfortunately, the supplier of our ordered, new fingerposts has ceased trading so we need to look for a new supplier.

A new plaque is currently being produced and should be delivered before the end of June.

Cllr Garvey has offered to provide two saplings, which can be nurtured before being planted out to replace Oak Tree 666 as requested by TRDC. This offer was gratefully accepted. It was also noted planting the new oak trees on the War Memorial side of the Green would inhibit the use of that section of the Green for events such as the May Fair. It was agreed to discuss with the Wildlife Volunteers alternative locations on the section of the Green where oak tree 666 was located.

# **151.BIGGERSTAFFS PLAQUE**

A 1.5 ft x 1 ft plaque has been agreed for the wall of the garage to commemorate the centenary anniversary of Biggerstaffs.

Chair and David Turner meeting with Andy Biggerstaff on 10 June to confirm final details.

### **152.CORRESPONDENCE**

A letter has been received from Edgar Anderson, our local representative for the Chiltern Society Rights of Way Group, proposing a bench in recognition and memory of the late John Goodman. It was agreed that subject to the family being supportive this was a good idea but it should be located somewhere other than Dawes Common which already has a large number of benches. Somewhere close to the Wildlife Sanctuary near Valley Farm might be a good alternative.
